

## **March 4, 2019 MILLCREEK-RICHLAND JOINT AUTHORITY MEETING**

Millcreek-Richland Joint Authority meeting of March 4, 2019 was brought to order by John Wolgemuth.

Members present were: Jan Klaus, Rebecca Schnoke (absent), John Wolgemuth, Hubert Risser, Lucas Blakeslee and Maybelle Morgan.

Secretary's report was read. A motion was made to approve the secretary's report by Hubert Risser and seconded by John Wolgemuth, all in favor.

Treasurer's report was read by Lucas Blakeslee. A motion was made to accept payment of all bills marked with an asterisk by John Wolgemuth, seconded by Jan Klaus, all in favor. A motion was made by Hubert Risser to accept the treasurer's report, seconded by Jan Klaus, all in favor.

George Savage was here to make sure that he is okay with EDU's to cover the four washer and dryers. We advised him that everything is okay with sewer authority.

John Zinn was here to go over our Insurance proposal for this year. Everything was reviewed and discussed. The total premium will be \$32,195.00.

Dan Hershey, Engineer – He advised that Myerstown reported we used 10%, which is good. Barry at the Myerstown plant is down to working on the small things to take care of in regard to the flooding damage. Once he gets all the costs in he will share. He also gave Myerstown the Chapter 94.

Ditchcreek is done with the televising and Dan printed maps for us to see and review. We now have all the information that can be incorporated in the GIS system when we want to do that. Dan will contact Pat and set up a time to get with us and he can advise and discuss what is needed to set up the GIS system and also give us a quote on the cost.

Henry Eberly – Ditchcreek was here and finished the project. Lines look good. As far as #2 Pump Station – pump is not running fast enough, pump time is different. Joe will be coming sometime this week. Henry advised they will be changing 4 contacts on the controller at pump station #2 and #4. Also advised that the snow blower was making a loud noise, he thinks it is in the blower, he will check it out.

Tom Harlan – Nothing. Jan questioned going in to a house to check if they are hooked up to a sump pump. Jan advised that Hamburg charges \$25 to each bill if they do not allow them to go into the house to check. Tom advised he will check on the Hamburg ordinance.

Correspondence – Received a request to order a copy of “The Pennsylvania and Federal Labor Law Poster” cost for 1 copy will be \$4.95 plus shipping and processing of \$5.95, need to get. Maybelle also advised that if the authority goes to Lowe’s we have a card to show so we can receive a 7% discount. They will be kept in a file for future use.

Delinquent accounts were reviewed.
