7) Gas monitor was repaired all is good with that.

8) Noticed there is an oil leak on the Jetter, will take out to Binkley & Hurst and see if they can repair.

Mike Kreiser gave a verbal report for the month of December 2019 a copy of report is attached. Mike advised they were getting a lot of alarms since Thanksgiving for Pump Station #2. Advised two pumps are running and then they get notified. For the time Justin made pump #1 the lead, but still do not know why this is happening. Also Justin had a call today from A.H Moyer wanting to know where to put lateral at 304 N. Race. It was discussed and found out to be 304 S Race St. Jan also asked since they had the problem with the air release valve he wanted to know it him and Justin could check out the others three and make sure they are okay.

Elvin Hurst, Ash Rd project has manhole and is hooked up, but it was not inspected and a sewer permit was never processed.
